Abstract: Lester Cleve Arnwine

Cleve was born in Oklahoma in 1931. His father worked for Conoco for 40 years, which required moves from Oklahoma to Texas and back during his elementary school years. After graduating as the 1948 high school class valedictorian at age 16, he enrolled at the University of Oklahoma (OU) to pursue a degree in Petroleum Engineering. In 1952, he and his ROTC classmates accepted commissions as army officers and served during the Korean War. His service in the Korean War resulted in a 3-year gap in his college education. He remained in the army reserves for 8 years following the war and continued Petroleum Engineering studies. He received a BS degree in 1956 and earned 26 hours of graduate credits while his fiancé completed her college degree.

Cleve joined Conoco in 1957 and enjoyed a stellar career in a number of key engineering and management positions spanning 35 years. He describes the highlights of his career as assignments in the Gulf of Mexico, Dubai and North America, which included two leadership positions in the control of 2 blowouts in Dubai.
