Abstract: Steven Douglas Monk

Steven Monk served in the military before working in law enforcement, primarily in Rosenberg, Texas. After the military, he worked at the Richmond State School in Richmond and as the Chief Investigator for abuse and neglect in the Victoria Child Welfare office. When he heard about a position with the Fort Bend County Juvenile Probation Department he applied and was accepted. He also worked for the Adult Probation Department before settling on the position of Chief Juvenile Probation when it came open.

Mr. Monk was Chief of Juvenile Probation when the jail was converted to the FBC Juvenile Detention Facility. Fort Bend County put juveniles in neighboring facilities until the FBC facility was opened. Travel for juveniles was a logistics nightmare until facility opened. He advocated for protections for kids brought to the facility. When he later earned a law degree he eventually left the Juvenile Detention system and practiced law. He spends a lot of his time defending juveniles and sometimes serves as an acting judge. He prefers being a lawyer. He knows the system and the principals handling cases and juveniles. He enjoys advocating for juveniles, many of whom deserve a second chance and respect.

Steven joined the military and volunteered for Vietnam but was assigned to Germany as a mortar man in the infantry.

After the military he went to work for the Richmond State School working with the profoundly handicapped.

He was hired by the Fort Bend County Juvenile Probation Department and accepted positions of ever increasing responsibility working with judges and lawyers to recommend sentences or treatment programs.

He decided to go to law school and later left the FBC Juvenile Detention Center only to return as an advocate for juveniles as a lawyer and part-time judge handling sentencing.
